The General Meeting for March will be on the 21st at 7:30 PM. We will again be hosted by Louis Buchner at his shop at 1030 Quesada Ave. in SF. We will try to start the meeting on time. Our primary presentation for the evening will be by a representative of the Borden Chemical Co., who will speak on current adhesive technology. Don Dupont will spotlight his beautiful side table which he displayed at the recent Working with Wood show in San Mateo. Louis Buchner will show a film on the wood working industry. We are also trying to arrange for a representative from Hafele to talk about their connecting hardware systems, although this presentation is less than certain at this time. We have discussed the purchase of a Tri-Pod easel marker board, which would facilitate presentations with diagrams. In accordance with our bylaws, we must vote approval on large expenditures. THE OREGON SCHOOL OF ARTS AND CRAFTS, Portland, Oregon is accepting applications for its 1985/86 Artists-in-Residence program. Applications will be accepted for residencies in Textiles, Print, Ceramics, Metal, and Wood. Slide deadline is March 31st.

The ten-month program is designed for both the early professional craftsperson seeking a transition from formal education to a professional career and the established craftsperson in need of respite. The residents are provided studio space, and given access to classes, all facilities, workshops and lectures. A group exhibition at the end of the residency is mounted in the school's Hoffman Gallery.

During the term of residency, the artists are encouraged to give slide lectures and/or workshops drawing on their area of expertise, as well as add vitality to the campus' creative environment through their presence. For prospectus:

SAM MALOOF. FURNITURE DESIGNER AT FORT MASON CENTER - APRIL 20, 1985

Hands on Wood, the San Francisco woodworking school, will host an all day work shop-demonstration by the furniture designer Sam Maloof. He has had a profound influence on a whole generation of American craftsmen. At the April 20 workshop he will demonstrate his remarkable freehand bandsaw techniques and go through the steps he employs in creating his famous chairs. The day will conclude with a film presentation and question and answer period. For registration and information call 567-2205. Maloof's work has been exhibited at the Vatican in Rome, the Smithsonian in Washington, and the American Craft Museum in New York. Iwelve of his chairs are in the permanent collection at the Museum of Fine Arts in Boston. Sam Maloof is considered by many to be the "father" of the California furniture style with its organic shapes and exposed joinery.


